7. Behaviour Policy

Foundations Holiday club aims to provide a safe environment for all the young people who attend, where children can develop self-esteem and confidence.

If your child behaves in a way which is unacceptable, the following steps will be taken:

- 1. We will speak to your child individually to get an understanding of the incident, we will try to re-engage your child in the activity taking place
- 2. If your child does not want to re-engage with the activity, there will be an opportunity for some time to reflect and calm down in a quiet space, as well as speaking through the incident with a member of staff (if that is what they want to do)
- 3. If the unacceptable behaviour continues, your child may not be able to continue with the activity, but will still be allowed to stay in the session
- 4. If the unacceptable behaviour does not stop, your child may be asked to leave the session. If this was to happen you will be informed and it will be agreed between the session leads, yourself and your child whether it is appropriate for your child to attend the next session.

Sending a child home is always our last option, and we will always work with your child to try to sort out any problems.
